1LT Huffstutler served as a Forward Observer and Aerial Observer with 4th Infantry Division Artillery. Camp Enari was under a 122mm rocket attack for the second night in a row when 1LT Huffstutler was tasked to serve as an Aerial Observer in an OH-6A Cayuse Helicopter piloted by WO1 James P. Casey. After directing artillery fire to suppress the attack the aircraft was to return to Camp Enari, however night fell and the weather turned bad. The helicopter crashed in an effort to divert to Camp Holloway. WO1 Casey and 1Lt Huffstutler were killed instantly and the crew chief died one week later.

Information from 9th VHPA reunion on James Patrick Casey: Camp Enari was under a 122 mm rocket attack for the second night in a row when WO1 James Patrick Casey scrambled with a 1LT aerial observer and a SP5 crew chief to direct artillery fire to suppress the attack. Casey was to return to Camp Enari, however night fell and the weather turned bad, so he tried to divert to Camp Holloway but crashed in route. Casey and the A/O were killed immediately and the Crew Chief died one week later. This is the same mission that CW2 Beck was killed on. I was Divarty Surgeon at the time Mr. Casey was killed. I recall that the commander, Col. Virgil "Bill" Williams, had plans to recommend Mr. Casey be commissioned posthumously to Lieutenant. I don't know if that happened. Casey was a good man. John C. On 13 November 1968, Lieutenant Huffstutler was attached to Company A, 1st Battalion, 35th Infantry, when it came under intense enemy mortar, rocket and small arms fire. Leaving the safety of his position, Lieutenant Huffstutler moved through the enemy fire and reorganized a platoon that had suffered heavy casualties. Displaying great tactical knowledge, Lieutenant Huffstutler was instrumental in the defenses of the perimeter and the capture of an enemy soldier.
